The 1995 E/M guidelines allow the physician to complete the physical exam by documenting organ systems or body areas. This approach is quite subjective and gives physicians a lot of leeway and “wiggle room.” On the other hand, the 1997 E/M guidelines are quite rigid and force physicians to document the exam using specific bullets. Physical Exam The physical exam rules are quite different for the 1995 and 1997 E/M guidelines. The 1995 exam rules may at first seem appealing to physicians because they are quite vague. You can basically document whatever you feel like documenting.

The first three of these components (i.e., history, examination and medical decision making) are the key components in selecting the level of E/M services. In the case of visits which consist predominantly of counseling or coordination of care, time is the key or controlling factor to qualify for a particular level of E/M service.
